



WARNING: Cell Towers Coming to Your Neighborhood!

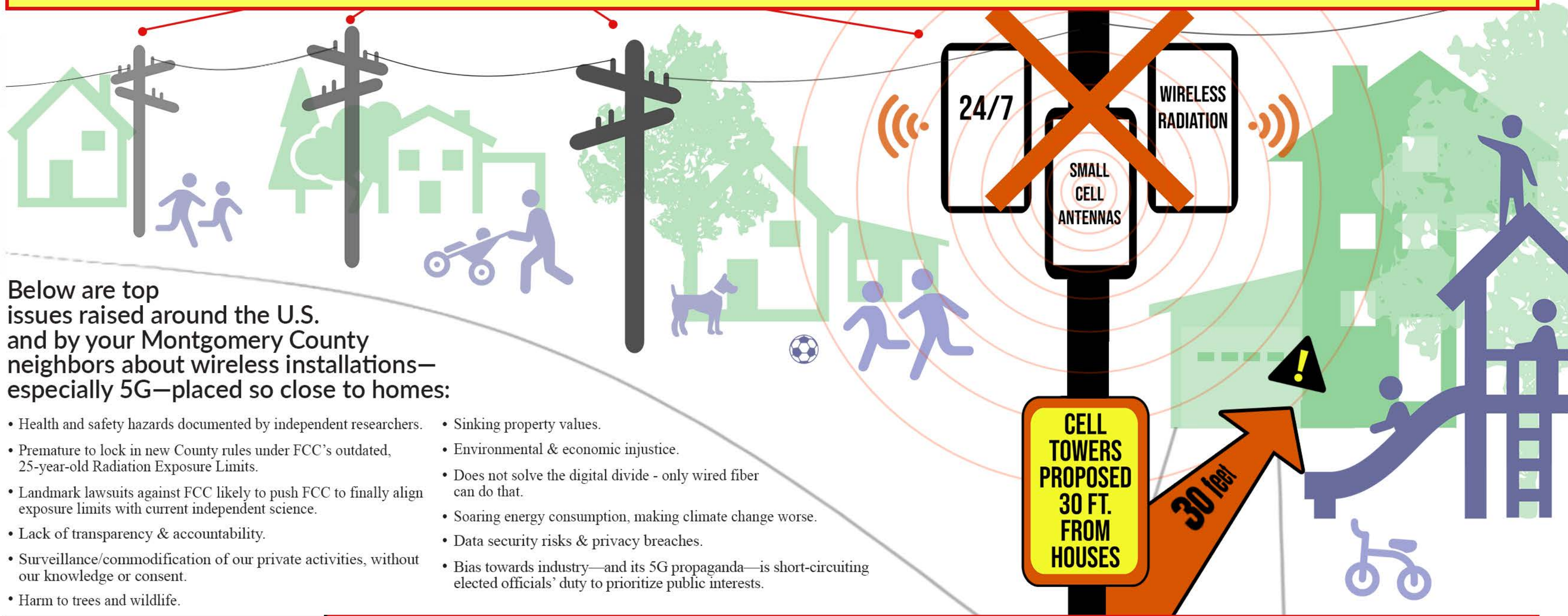


Montgomery County Council will vote soon on ZTA 19-07, which allows cell towers 30 feet—or less!—from our homes. Without a public hearing or your permission, telecom carriers would install a 4G/5G wireless cell tower 30 feet from your home and just 150 feet apart—which could be every 2 to 3 homes. **With a special permit, cell towers would be allowed even closer.**

Independent scientists, environmental leaders, and concerned residents are demanding the FCC update their 25-year-old exposure limits for radio-frequency radiation. They urge caution on the rollout of 4G/5G and other wireless installations on earth and in space until proven safe.

Join us in Montgomery County, MD to resist 5G and other cell towers near schools, playgrounds & homes—and help us to defeat ZTA 19-07.

ZTA 19-07 is unfriendly to residents. It seeks to make it faster, cheaper, and easier for Big Wireless to put cell towers throughout our neighborhoods—without public notice or hearings. Industry admits that 5G antennas can transmit 3,000 feet. Why put them 30 feet from our bedroom windows? Our environment, property values, privacy, climate, health and digital equity are better served by wired fiber for Internet access—which is a safer, cheaper, more reliable, and greener technology.



Below are top issues raised around the U.S. and by your Montgomery County neighbors about wireless installations—especially 5G—placed so close to homes:

- Health and safety hazards documented by independent researchers.
- Premature to lock in new County rules under FCC's outdated, 25-year-old Radiation Exposure Limits.
- Landmark lawsuits against FCC likely to push FCC to finally align exposure limits with current independent science.
- Lack of transparency & accountability.
- Surveillance/commodification of our private activities, without our knowledge or consent.
- Harm to trees and wildlife.
- Sinking property values.
- Environmental & economic injustice.
- Does not solve the digital divide - only wired fiber can do that.
- Soaring energy consumption, making climate change worse.
- Data security risks & privacy breaches.
- Bias towards industry—and its 5G propaganda—is short-circuiting elected officials' duty to prioritize public interests.
